

Recommendations for the Use of the Data Holder Rights Exercise Form

The reason for including this form (see page 2) is aimed at improving communication and assisting in the execution of the request for the exercise of rights as established in the new General Data Protection Regulations (RGPD) and it is recommended by the AEPD. PADEL NUESTRO (PN) presents the following form to exercise the **right of Portability**. We should inform you that the data that has been stored from you derived from the forms or communications established for this purpose, will be blocked in order to be able to prove the management and maintenance of the same (data / documents) for a period of 5 years.

The right of Portability is one of the rights that the Organic Law of Protection of Personal Data (LOPD) recognizes to the citizens so that they can control by themselves the use made of their personal data, and in particular, the right to transmit your data to a third party (new responsible) according to the conditions established in the RGPD on whether they are being processed. This exercise is very personal, so it can only be requested by the person concerned, who should contact the company or public body that knows or presumes that they have their data, and can choose to view them directly on screen or obtain them by writing, copy, photocopy or any other system appropriate to the type of file in question. The new right for data portability can be exercised: (a) When data processing is done by automated means (b) When the treatment is based on the consent or in a contract (c) When the user requests it with respect to the data that he himself has provided to who is treating them and who are concerned, including data derived from their own activity. However, it is not applicable: (a) To the data that the user has provided about third parties (b) In the event that the user has requested the portability of data that concern him but that have been provided to the person responsible through third parties.

Procedure to use this form:
