

Recommendations for the Use of the Data Holder Rights Exercise Form

The reason for including this form (see page 2) is aimed at improving communication and assisting in the execution of the request for the exercise of rights as established in the new General Data Protection Regulations (RGPD) and it is recommended by the AEPD. PADEL NUESTRO (PN) presents the following form to [exercise the Right of opposition](#). We should inform you that the data that has been stored from you derived from the forms or communications established for this purpose, will be blocked in order to be able to prove the management and maintenance of the same (data / documents) for a period of 5 years.

The right of opposition is one of the rights that the Organic Law of Protection of Personal Data (LOPD) recognizes citizens so they can defend their privacy by controlling for themselves the use made of their personal data, and in particular, the right for the treatment of those data is not carried out or ceased when the consent is not necessary for the treatment or the concurrence of a legitimate and well-founded reason, referred to their concrete personal situation, that justifies it, and provided that a Law does not provide otherwise. Its exercise is very personal, so that only the interested person can do it by means of a request addressed to the person responsible for the treatment, in which the well-founded and legitimate reasons that justify it must be stated.

The person in charge of the file or treatment, within a maximum period of ten days from the reception of the request, must resolve on it, excluding from the treatment the data relative to the affected or rejecting the same. You must also do so even if you do not have data of the affected party. After the deadline without expressly responding to the request or it is unsatisfactory, the interested party may file the corresponding claim for protection before the Agency.

Procedure to use this form:
